



Request for Girl Scout Plan 2 Activity Accident Insurance

Girl Scout Plan 2 Activity Accident Insurance is required for:

- Members attending or participating in an event lasting more than two (2) consecutive nights.
- Non-members attending or participating in any Girl Scout approved, supervised activity regardless of the length of the event.

Girl Scout Plan 2 Activity Accident Insurance covers:

- Basic accident protection for attending or participating member for events lasting more than two consecutive nights, non-members with no event duration time frame.
- Travel directly to and from the covered activities.
- Injuries which result in treatment beginning thirty (30) days after the date of a covered accident.

Girl Scout Plan 2 Activity Accident Insurance costs:

- Insurance must be ordered for the entire period of the event and for 100% of the participants -except for members already covered under Girl Scout Plan 1 Activity Accident Insurance (less than two overnights).
- The cost is \$0.11 per person, per calendar day or portion thereof.
- There is no minimum premium per event.
- There is a \$5.00 minimum that is applied to each online submission of an enrollment form.
- This online request form allows up to fifteen (15) events to be listed on an enrollment form.

All claims are subject to review by Mutual of Omaha.

Process

- Upon your request (submission of this form), Girl Scouts Heart of New Jersey will purchase ***Girl Scout Plan 2 Activity Accident Insurance***, paying the insurance premium on your behalf to Mutual of Omaha.
- Event Coordinator will receive an email with Mutual of Omaha Invoice Statement and supporting documents.
- Event Coordinator will submit payment by check to Girl Scouts Heart of New Jersey Finance Department.

- Copies of documents can be accessed by your Service Unit Specialist or Membership Specialist.
- This process may take up to five (5) business days.

What is Girl Scout Plan 2 Activity Accident Insurance?

Girl Scout Plan 2 Activity Accident Insurance provides basic accident protection for:

- Members for events lasting more than two (2) consecutive nights.
- Non-members attending or participating in any Girl Scout approved, supervised activity regardless of the length of the event.

What is an approved, supervised Girl Scout Activity?

An approved, supervised Girl Scout activity is an activity carried out by Members of the Movement, under the supervision of adults, in keeping with the Girl Scout Program Standards.

When is Girl Scout Plan 2 Activity Accident Insurance required?

Any person attending or participating in any Girl Scout activity must be a registered member of Girl Scouts or covered by appropriate Girl Scout Insurance.

Girl Scout Plan 2 Activity Accident Insurance is required for:

- Members attending or participating in an event lasting more than two (2) consecutive nights.
- Non-members attending or participating in any Girl Scout approved, supervised activity regardless of the length of the event.

Who is eligible for Girl Scout Plan 2 Activity Accident Insurance?

Persons attending or participating in a chartered Girl Scout Council approved, supervised activity for whom an enrollment form has been submitted and premium paid.

When does coverage become active for Girl Scout Plan 2 Activity Accident Insurance?

Once an enrollment form has been submitted and premium paid, the participant is automatically covered for accidents or injuries that occur during their dates of coverage while attending or participating in any Girl Scout approved, supervised activity.

What does Girl Scout Plan 2 Activity Accident Insurance cover?

- Basic accident protection for attending or participating member for events lasting more than two consecutive nights, non-members with no event duration time frame.
- Travel directly to and from the covered activities.
- Injuries which result in treatment beginning thirty (30) days after the date of a covered accident.
- Benefits include accident medical expense, dental expense, ambulance expense, non-duplication provision, infectious exposure benefit, accidental death, dismemberment and paralysis benefits, heart or circulatory malfunction benefit.

All claims are subject to review by Mutual of Omaha.

What is the cost for Girl Scout Plan 2 Activity Accident Insurance?

- Insurance must be ordered for the entire period of the event and for 100% of the participants.
- There is no minimum premium per event.
- There is a \$5.00 minimum that is applied to each online submission of an enrollment form.
- This online request form allows up to fifteen (15) events to be listed on an enrollment form.

All claims are subject to review by Mutual of Omaha.
